O R D E R:

In the circumstances reported by the Secretary, TSBIE, Hyderabad and Commissioner of Technical Education & Convenor, TSCET Admissions, Hyderabad in the reference 9<sup>th</sup> & 10<sup>th</sup> read above, and as advised by Learned Advocate General in the reference 8<sup>th</sup> read above, Government after careful examination in the matter and in view of the extraordinary circumstances prevailing due to the COVID Pandemic -2019 in the State, have been decided that the sub-clause (ii) of Clause-2 as contemplated under the TS EAMCET-2020 Exams Notification shall not apply in respect of those students who have passed 10+2 examination and who qualified for TS-EAMCET-2020 and also decided that to direct TS-EAMCET-2020 authorities to permit such students to appear for counseling in respect of TS EAMCET (Admissions)-2020, without insisting the eligibility criteria for qualifying examination marks. This order applies only for this year i.e 2020-2021 as a special case and shall not be made as precedent in future, and shall not be applied from 2021-2022 onwards.

2. The Secretary, Telangana State Council of Higher Education, Hyderabad shall take necessary action accordingly.
